TRANSFER OF LANDS TO THE FISH AND WILDLIFE SERVICE: Jim Becic gave an overview of the plan to transfer land to the Fish and Wildlife Service. Brian Shultz of the

Fish & Wildlife Service answered questions about staffing and canoe access at Boyer Chute.

• IT WAS MOVED by Conley, and seconded by Lanphier, that the Subcommittee recommend to the Board that the General Manager be authorized to sign the Agreement for the Purchase of Lands transferring ownership to the United States Fish and Wildlife Service of the 250 acre Nathan's Lake site, the 400.17 acre Stratbucker property, the 40.43 acre Nebraska Board of Educational lands and Funds parcel and the 19.96 acre Roger's tract, more or less, for the price of \$54,000, subject to changes deemed necessary by the General Manager and approved as to form by District Legal Counsel..

G&G PROPERTY DONATION FOR ELKHORN RIVER PUBLIC ACCESS SITE: Dick Sklenar gave an overview of the location of the donated property (SE corner of West Dodge Road and the Elkhorn River) by the Graske family and plans for the site. It was noted that the Graske's had verbally agreed that the site name listed in the covenants being requested could be shortened when used in publications, signage, etc.

 IT WAS MOVED by Tesar, and seconded by Thompson, that the Subcommittee recommend to the Board of Directors that the General Manager be authorized to execute the restricted covenant and accept donated property from G&G Manufacturing Co. for the future establishment of a West Dodge Road public access site to the Elkhorn River.
