Notice of Proposed Acquisition and Notice of Public Hearing

WESTERN DOUGLAS COUNTY TRAIL PROJECT – PHASE 1 (Valley to Waterloo)

The Papio-Missouri River Natural Resources District (hereinafter referred to as "the District") proposes to acquire certain tract(s) of real estate in Sections 4, 5, 6 and 9, Township 15 North, Range 10 East of the 6th P.M., and Section 31, Township 16 North, Range 10 East of the 6th P.M., Douglas County, Nebraska, which you own or in which you may have a right or interest (such tracts hereinafter referred to collectively as "the Property", whether one tract or more).

1. The property to be acquired and the compensation to be given for the property:

The compensation to be offered for the Property will be the damages as appraised by licensed real estate appraisers, generally consisting of the fair market value of the Property, or the fair market value of the interest in or portion of the Property acquired plus any difference between the fair market value of the remainder of the Property before and after the acquisition.

2. The authority for the acquisition:

The District's authority for the proposed acquisitions is contained in Nebraska Revised Statutes, Section 2-3229, et.seq.

3. The nature of, necessity, and purpose for which the land shall be used:

The property proposed to be acquired will be used for the construction, operation, and maintenance of the Western Douglas County Trail Project.

4. The right, title, or interest in the property to be acquired:

The District proposes to acquire fee simple title to certain lands required for the project, including the land upon which the Project's improvements will be constructed, operated and maintained; and proposes to acquire temporary and permanent easements over adjacent lands as required for the Project.

5. The amount of property needed:

The square footage amounts, set out in the legal descriptions attached to this notice and incorporated herein by reference, are required for the Project.

6. The reasons for selecting the proposed location or route:

The Project will generally follow the West Maple Road and 264th Street transportation corridors to connect the communities of Valley and Waterloo. A map of the proposed route for the trail is attached hereto and incorporated herein by reference.

7. Approval required from other agencies:

None.

NOTICE OF PUBLIC HEARING

Please take notice that on May 8, 2008, at 8:00 p.m., the Board of Directors of the Papio-Missouri River Natural Resources District will hold a public hearing on the Western Douglas County Trail Project which is located between the City of Valley and the Village of Waterloo, and on the acquisition of real property for the project. Such hearing will be held at the principal offices of the District at 8901 South 154th Street, Omaha, Nebraska 68138-3621.

At the hearing, the District shall explain the nature and necessity for the project, the reasons for selecting the particular location, and the right of each owner of property to be represented by an attorney and to negotiate and accept of reject the offer of damages which will be sustained by the proposed acquisition, and the right to require that such damages be determined pursuant to the procedures for acquisition by eminent domain. The District shall hear and consider any objections from any person.
