<u>Calculation:</u> GM Winkler noted that the District has the ability to increase the base restricted fund authority by 2.5% in the FY 2010 budget. The Board can also take action to exceed the limit by 1%. This would require a super majority of the Board or 9 affirmative votes. It was noted that this was not a 1% increase in taxes, but a 1% increase in the District's restricted fund authority. The lid applies to general expenditures such as Directors' per diem and expenditures, insurance coverage, vehicles/equipment, etc. This item will be on the June FEL agenda.

<u>Papio WP-5 Right of Way Acquisition</u>: Amanda Grint reported that staff had anticipated having a signed agreement for right of way parcel at Papio WP-5. One of the parties is out of town so the agreement did not get signed. This item will be on the June FEL agenda.
