PROOF OF PUBLICATION: Public notice of the meeting was posted at all District offices and published in the Omaha World-Herald on November 12, 2006. The proof of publication affidavit is included with the file copy of these minutes.

P-MRNRD PARTICIPATION IN NARD FLEXIBLE BENEFITS PLAN: Pat Teer reported that the NARD Board of Directors approved the NARD Flexible Benefits Plan (Section 125 Cafeteria Plan) at their September 26, 2006 meeting. The major advantage of this plan is that employee's contributions for group health and dental premiums, the Health Flexible Spending Accounts and the Dependent Care Flexible Spending Accounts are deducted from the gross wages on a pre-tax basis. The plan features three benefits options:

- 1. Insurance Premium Payment Option This allows participants to pay for dependent coverage with pre-tax dollars. This option is currently available to District employees.
- 2. Health Flexible Spending Account This will allow employees to pay for medical expenses not covered under the insurance plan, i.e., deductibles, \$30 co-pay for office visits; prescription drug co-pays, dental co-pays, etc., with pre-tax dollars. Employee contributions to the Health Flexible Spending Account cannot exceed \$2,400 during the plan year. The minimum contribution is \$40/month to offset administrative costs.
- 3. Dependent Care Flexible Spending Account This option would allow participants to pay for dependant care with pre-tax dollars. In most cases employee contributions shall not exceed \$5,000 during the plan year.

Employee participation in the plan is on a voluntary basis.

✤ It was moved by Director Fred Conley and seconded by Director Jansen that the Subcommittee recommend to the Board that the Acting General Manager be authorized to execute the Participation Agreement between the Nebraska Association of Resources Districts and the Papio-Missouri River NRD; that the District participate in all three options of the plan; that the effective date for P-MRNRD participation be January 1, 2007; and, that the resolution provided by the NARD be adopted.
