SERVICES FOR THE WASHINGTON COUNTY FLOOD PLAIN MAPPING PROJECT: Marlin Petermann briefed the subcommittee on the process undertaken to date to review and recommend a contract with Kirkham Michael/AMEC to provide engineering services for the Washington County Flood Plain Mapping project. Kirkham Michael/AMEC will be responsible for providing project management, incorporating recent flood studies and preparing preliminary DFIRM maps conforming with FEMA standards, for a total fee of \$204,483. The preliminary maps will be ready by the end of May, 2009. Roger Helgoth, KMA, addressed the Subcommittee to respond to questions.
