# REVIEW AND RECOMMENDATION ON WEST BRANCH CHANNEL PROJECT (FORMER UNION PACIFIC RAILROAD) ROW SALE TO SARPY COUNTY – MARTIN CLEVELAND:

Martin Cleveland reviewed with the Subcommittee the Sarpy County request to purchase property and temporary easements over NRD Property (Former Union Pacific Railroad right-of-way) to construct Cornhusker Road improvements between 108<sup>th</sup> and 100<sup>th</sup> Street. He noted that

the purchase price was set by a recent appraisal conducted by the County appraiser (Ag One Appraisals). There was discussion about the Channel Project and road drainage impacts.

### FY2004 Budget - Final Levy = 0.030637 (Last Year's Tax Levy = 0.030729) - Steve Oltmans:

Steve Oltmans discussed the Fiscal Year 2004 property tax levy requirements to meet the property tax request of \$10,701,211.59 and the total requirements at \$24,091,018.34 and noted that the levy will decrease from 0.030729 to 0.030637 as a request of increased property valuations.

NOW THEREFORE BE IT RESOLVED that the tax levy of 0.030637/\$100 for FY 2004 be adopted and that certified copies of this resolution and the adopted budget document be forwarded to the County Clerks of counties having taxable property within the District.
